### **Registration Opens for NCPO/ABA Events**

The 39<sup>th</sup> Annual Forum on Client Protection and NCPO's Annual Workshop have been scheduled for 2023 – the first time both events have occurred in-person since 2019. Here are the specifics for these two opportunities to learn about and network with funds from across the U.S. and Canada.

The ABA Forum travels to New Orleans for two days of sessions on June 2 and 3, 2023. On the top of the list for most funds right now is understanding – and dealing with – the decline in the number of filed claims since the onset of the pandemic. Is this the "new normal" or are there other issues in play? How can funds make sure they are easily found by potential claimants? What are strategies for dealing with those difficult claims, particularly involving deceased attorneys? # Hide & Seek?

### **How Accessible is YOUR Fund?**

For a fund to successfully redress the loss of a client victim of attorney theft two things must happen at the very beginning of the process: (1) The client must be able to find the fund in their jurisdiction and (2) The fund's claim form must be accessible and straight-forward. Sometimes, what seems simple to us (since we see it every day) is not so simple for a potential claimant.

It's from this perspective that NCPO's presidentelect, Gabe Huertas of New York, conducted a survey of every U.S. fund. Gabe looked for each fund's website. He checked to see how easy they were to find and navigate, and this is what he discovered:

Each of the 50 states and the District of Columbia have client protection fund web pages. At the time Gabe checked, 50 were in working order and only 1 was not.



6 funds maintain a web page independent of their respective judiciary or bar association. The others have subpages that are found under their judiciary or bar association websites.

5 funds have direct links to their web page located on their judiciary or bar association home page. The others require you to click through two or more links on the judiciary or bar association home page before arriving at the fund web page.

. Using their respective names, all Funds appeared in Yahoo, Bing and Google search queries as the first search result.

35 funds maintain direct contact information (email, telephone number) on their respective web pages. The others do not and require a potential claimant to contact a general judiciary or bar association telephone number or email.

40 funds have made their reimbursement application available on their web page. The others require potential claimants to make contact by telephone or email for application materials.

39 funds have made their statutory/regulatory authority available on their web page.

23 funds have made their annual report available on their web page.

The survey shows funds have made progress improving their accessibility, but much remains to be done. NCPO can help your fund improve its visibility on the web and in your community so that potential claimants can easily find you and know when and how to file a claim. Funding is available through NCPO's grant program. As a first step, check your fund's listing on NCPO's website map to make sure it is up-to-date and complete with working links to everything a potential claimant might need. ### <u>NCPO Outreach</u> Virgin Islands, Guam are fund candidates

Every jurisdiction should have a client protection fund. This basic principle is the impetus to NCPO's outreach effort to the U.S. Virgin Islands and Guam. There are about 1,000 practicing attorneys in the U.S. Virgin Islands, centered mostly on the island of St. Thomas.



The territory is part of the U.S. Third Circuit and first started considering the creation of a fund almost ten years ago. The effort was pushed back when several hurricanes devastated the islands. Now Mike Knight of New York, former NCPO president, and Ken Bossong, an NCPO founder and former director of the New Jersey

Fund, have connected with the Island's Judiciary, which has expressed renewed interest in establishing a fund.

The Guam Bar counts approximately 270 practicing attorneys. The small number of attorneys creates the opportunity to engage the entire bar. It may also make it possible to create a partnership with an already established fund, although the nearest one (Hawaii) is still almost 4,000 miles away. Clearly a unique situation, Guam is nonetheless part of the U.S. and should be included in the client protection community. NCPO is looking forward to a process that is educational, collaborative and productive for the people of Guam as well as for the rest of us "stateside."



## Vermont Fund Prepares for 65<sup>th</sup> Year

The first client protection fund was established in New Zealand in 1929. It would be 31 years before the concept of client protection made it across the globe to the United States with the creation of the first American fund in Vermont in 1959. Another 49 states and the District of Columbia would follow with funds of their own, but Vermont was first. It's a distinction worth celebrating with a renewed commitment to the Vermont Fund and the important role it can play in maintaining client trust in the legal profession and our system of justice.

Members of NCPO's outreach committee will travel to the state capital of Montpelier to meet with the Vermont Bar Association trustees who oversee the Fund. The delegation will discuss how the Vermont Fund can meet the challenges of accessibility and effectiveness that are common to all funds. The Bar is relatively small – about 2,200



members – offering the opportunity to engage attorneys in the Fund's mission on multiple levels: pride in their support of the Fund as well as familiarity with what it does and how, so that it can be utilized easily when needed.

The meeting, scheduled for April 21, 2023, part is of NCPO's mission to support member funds. bringing By NCPO's expertise directly to the Vermont Fund, we can



build a stronger relationship better able to put NCPO resources to work for specific needs in Vermont. How can your fund benefit from an NCPO visit? (There is no cost to you.) #### Associate's Charges Take Down Senior Partner in PA



Kimberly J. Simon-Pratt, 56, the custody, dependency and juvenile hearing officer in Greene County, Pennsylvania, has been charged with stealing \$22,213 in retainer fees from 27 clients. In an unusual twist, the crime was reported to authorities by another attorney who worked for Simon-Pratt's law firm who alleged that she (not Simon-Pratt) should have been paid the \$22,213 in fees for services rendered to the firm's clients.

Simon-Pratt managed her law firm, worked in the County Courthouse, and last year was an unsuccessful candidate for a judgeship in the court of Common Pleas. She is free on unsecured bond while the charges are pending.

the New York Lawyers' Fund, Michael has played a vital role in reimbursing victims of dishonest lawyers, as well as in the administration and oversight of several New York regulatory rules for the benefit of law client victims. Initiatives championed by Michael include the dishonored check reporting rule; missing client and deceased attorney funds rule; and Insurance Regulation 64, requiring

payee notification. Most recently, he was instrumental in the expansion of the dishonored check reporting rule to include overdraft notifications.

Michael has provided countless lectures throughout New York state with bar associations and continuing legal education programs, educating New York attorneys on how to comply with their fiduciary and escrow obligations and avoid situations that can result in losses.

It is because of Michael's dedication and service to the New York Lawyers' Fund that it has become one of the foremost client protection programs in the nation. He served as NCPO's president, participates in virtually all NCPO workshops and ABA Forums, and is clearly a "go to" person whose experience, knowledge, grace and wit has helped so many of us in the field. In his many roles, Michael has been the consummate ambassador of the ideals of law client protection.

# **Lottery Lawyer's Luck Runs Out**



New York's Jason Kurland, known as the "Lottery Lawyer" was convicted in Brooklyn recently of defrauding his lottery-winning clients out of \$107 million. Federal Prosecutors proved that Kurland steered his clients to invest millions of dollars in companies that he secretly owned and took illegal kickbacks based on his clients' investments without their knowledge. His clients had collectively won an estimated \$3 billion. Kurland, who pled not guilty, argued that he had been deceived by other defendants about the true nature of the investments he was proposing to his clients.

# "My mother would be so disappointed..."

Former Hendersonville, Tennessee attorney Andy Allman was sentenced to 35 years in prison for stealing \$1.1 million from 212 law clients. "This is massive," the sentencing judge said. "I've never seen a case like this that affects the way we do justice in a state court..."

During a nine-day trial in which Allman represented himself, victims described handing money over to Allman, either to hold in a trust account or for a retainer fee, only to receive little or nothing in return. Allman & Associates employees described a bustling law firm with more than 200 clients, yet their paychecks would sometimes bounce for lack of funds.



"My mother would be so disappointed in you," one client said at Andy Allman sentencing. "You could have done the right thing – but it's not in your soul to do the right thing." Allman has yet to make any restitution.
