ABA Plans Survey, Forum

ABA Public Protection Committee Update

The Public
Protection
Committee has
formed a subcommittee
focused on the
development of a resource
to assist in attorney
succession planning. The
subcommittee has a goal of
building a best practices
guide/model for use in
assisting attorneys in

designating a successor attorney and ensuring that their practice and clients are protected should the attorney become suddenly



unavailable due to unexpected death, disability, or absence.

The Committee has also formed a subcommittee that is considering development of ABA policy on UPL enforcement procedures. This

subcommittee has begun updating a database that will be a resource for members look up UPL rules and enforcement

entities by jurisdiction.

2017-2019 Survey of Lawyer's Funds for Client Protection Update

Last quarter the Public Protection Committee in partnership with NCPO wrapped up their response collection efforts for the triennial ABA Survey of Lawyers' Funds for Client Protection. The survey collected data from Lawyers' Funds in the U.S.



and Canada for 2017, 2018, and 2019, and covered a variety of topics such as Fund Authorization and Administration, Fund Finances, Fund Claims Experiences, and Fund Loss Experiences. The response rate of over 83%, represents a high for the publication. Work is currently being done to analyze the data with plans to publish the results of the survey in late 2020 /early 2021. This ABA Survey remains the only national compilation of data on Lawyer's Funds across the U.S. and Canada and is used to spot emerging trends in client protection claims, determine the number of claims paid nationwide, and identify the similarities and differences between various Fund operations. The Public Protection Committee's goal is that it remains an invaluable resource to the Client Protection Community.

36th National Client Protection Forum Plans are underway for 36th National Forum on Client Protection. The Committee is planning to host the Forum as a virtual event on June 4, 2021 in conjunction with the ABA National Conference on Professional Responsibility, scheduled for June 2-4, 2021 which is also going virtual. The Committee is hopeful that the tradition of hosting a live Forum will resume for the 2022 Forum in Baltimore but in the meantime, it is looking forward to bringing some exciting and innovative programming to 2021's virtual format. Session topics will include innovations in Client Protection Fund claims processes, exploring and preparing for future successes and challenges, a program discussing Client Protection Funds and alternative legal service provider programs and a joint session with the National Conference on Professional Responsibility. The Committee also plans to incorporate a virtual social/networking event into the Forum to preserve the interaction and camaraderie among colleagues that has long been an integral and

treasured aspect of the event. Registration details for both the National Client Protection Forum and the National Conference on Professional Responsibility will be announced soon.

Other ABA Updates

The ABA will hold its Midyear Meeting February 17-22, 2021. The 2021 Midyear, like the 2020 Annual meeting held this past July, will be a virtual event. In addition to holding its biannual meeting of the ABA House of Delegates, the ABA plans to offer a broad range of programming throughout the week, many of which will be eligible for CLE credit in most jurisdictions. Registration for this event is free to all current ABA members. More information is available on the ABA's website.

Hawaii Fund Salutes its "Dean" – Michael Miyahira to Retire After Quarter Century of Service

The fellow trustees of the Hawaii Lawyers' Fund give a warm salute to Michael Miyahira on his retirement from the Hawaii Lawyers' Fund after 25 years of loyal service to the Hawaii Lawyers' Fund and legal community.

Mike is the dean of Hawaii's Lawyers' Fund, having guided the Fund as its chairman for more than a decade. Mike was first appointed as a trustee to the Fund in 1995, and in the two and a half decades since, Mike has been instrumental in bringing to bear many contributions and improvements to client protection in Hawaii. An affable, good-natured, and friendly gentleman from the Big Island of Hawaii, Mike brought his warmth to the national client protection stage, having served as President of the National Client Protection

Organization from 2011 to 2014. Mike's dedication to the protection of legal clients combined with his ability to work with others across the nation was a service to our State where the need to protect the interests of legal clients had previously been overlooked and underappreciated. Through his dedication to unfortunate clients of dishonest attorneys, his commitment to the virtues of the Fund, and his camaraderie with similarly devoted professionals from other states, Mike improved and modernized Hawaii's Lawyers' Fund to serve the needs of our legal community.

During his 25 years of volunteer service, Mike met with members of the Hawaii Supreme Court, the bar association, the disciplinary counsel and other government agencies on behalf of the Lawyers' Fund. He was instrumental in incorporating many innovations to the Hawaii Lawyers' Fund; most

importantly, the increase in the maximum amount of compensable awards to clients, the enactment of the loss payee notification rule, and the Lawyers' Fund's computerized case management system. Due to Mike's hard work, dedication, and lobbying efforts, the Lawyers' Fund's award limits were amended to increase the maximum amount awardable to a wronged client to \$100,000, with a maximum aggregate of \$300,000 per attorney. Under Hawaii's adoption of the loss payee notification rule, enacted by Mike's substantial efforts, insurers are now required to give written notice directly to claimants of the amount of settlement payments made to claimants'



attorneys. After many discussions with sister states as to their efforts to computerize the cases involving lawyers' fund claims, and after several attempts to get a computerized case management system operational in Hawaii stalled, the Lawyers' Fund's case management system came online under Mike's leadership in 2019. Mike has truly been an inspiration to us all, and sets the standard of volunteer service by which all trustees strive to achieve.

Mike's dedication to the Lawyers' Fund and NCPO is evident in the extra efforts he made to travel from Hilo, Big Island to the annual NCPO and ABA meetings and workshops held in places ranging from Albuquerque, New Mexico to Little Rock, Arkansas and even all the way to Portland, Maine. Mike must have logged in hundreds of hours traveling in cars, buses, cabs and airplanes and waiting in numerous airport lobbies to represent Hawaii on the mainland. The Fund appreciates Mike's grit, determination and enormous tolerance for long-distance traveling!



We bid a fond Aloha to Mike, thank him for his innumerable contributions and immeasurable hours volunteering with the Hawaii Lawyers' Fund, and wish him well in his retirement from the Fund during which we expect he will be spending halcyon afternoons lounging on Hilo Bay.

The Hawaii Lawyers' Fund is a client reimbursement program organized in 1981 and financed entirely by Hawaii attorneys. The Fund reimburses law clients for financial losses caused by their attorney's dishonest conduct in the practice of law. The Lawyers' Fund's financing comes from a portion of the registration fees paid by Hawaii's attorneys. No taxpayer money is used for this client protection program. All claims are settled by the Trustees with investigative and administrative assistance from the Office of Disciplinary Counsel, an agency of the Hawaii Supreme Court.

The Hawaii Lawyers' Fund is administered by a five-member Board of Trustees appointed by the Hawaii Supreme Court. The Trustees serve without compensation. The types of losses covered by the Lawyers' Fund include a lawyer's theft of money, diversion of settlement payments received on behalf of clients, and client monies embezzled by the attorney. The Fund has no authority to compensate for malpractice or to resolve disputes over legal fees charged by the attorney.
